SUMMARY OF THE PROCEEDINGS OF 30TH ANNUAL GENERAL MEETING

DATE, TIME AND VENUE OF THE MEETING

• The 30th Annual General Meeting of the Company was held on Wednesday, 21st September 2022 at 11.30 AM through Video Conferencing.

PROCEEDINGS IN BRIEF

- Mr. Sushil Parakh, Chairman & Managing Director of the Company occupied the chair.
- Total 37 members including members from Promoter group were present in the meeting.
- As per Section 103 of the Companies Act, 103 the required quorum for convening the AGM was present, accordingly the Chairman called the meeting in order.
- The Chairman informed to the members that the Company is in compliance the requirement of applicable Act and the Rules and the Secretarial Standards made there under with respect to calling, convening and conducting the meeting.
- The Chairman welcomed the Members to the 30th AGM of the Company through Video Conferencing (VC). The Chairman introduced the Directors present and Round Call was taken. He informed that since the meeting was being conducted through VC there was no requirement for proxies. He further informed that the Register of Members, Register of Director's and Key Managerial Personnel and their shareholding, Register of Contracts, etc. were kept open for inspection by Members and the same were accessible in electronic mode to those shareholders who shall place request for the same.
- With the consent of the Members present the notice of the 30th AGM and the Auditor's Report were taken as read by the Chairman.
- The Chairman read out the details of remote e-voting and instructions for AGM. He stated that in accordance with the provisions of the Companies Act, 2013, and the rules made thereunder, the remote e-voting facility for voting on the resolution(s) contained in the Notice of the 30th AGM was provided to the Members of the Company from 9.00 am on 18th September 2022 and up to 5.00 pm on 20th September, 2022 and that the e-voting module was closed by NSDL thereafter.
- Three members had registered as speaker for the AGM. The queries raised by the Members at the meeting were suitably replied by the Chairman & Managing Director. The Chairman thereafter requested those Members who had not voted through remote e-voting; to vote through the e-voting process provided at the AGM. Mrs. Gayatri Phatak, Practicing Company Secretary was appointed as Scrutinizer for scrutinizing the remote e-voting and e-voting at the AGM.
- The following items of business as set out in the notice convening 30th AGM were placed for members' consideration and approval.

RESOLUTION(S)

Ordinary Business:

- i. To receive, consider and adopt the audited Standalone Financial Statements of the Company for the financial year ended March 31, 2022 along with the Reports of the Board of Directors and the Auditors thereon.
- ii. To appoint Directors in place of Mr. Sushil Parakh (DIN: 02596801), who retires by rotation, being eligible, offers himself for re-appointment.

Special Business:

- Sub-Division of Equity Shares of the Company from Rs. 10/- (Rupees Ten only) each to Re. 1/-(Rupee One) each
- iv. To alter Capital Clause of Memorandum of Association
- The Chairman thereafter informed that the Result of the voting will be declared after counting of votes cast through e-voting during the AGM and votes cast by remote e-voting prior to the AGM as per the report of the Scrutinizer and that the results of the voting will be intimated to the Stock Exchanges and also uploaded on the website of the Company in due course of time.
- The meeting concluded with a vote of thanks to the Chair at 12.15 prn.

VOTING BY MEMBERS:

- The Company had provided remote e-voting facility to its members to cast votes electronically on all three items of business set out in the Notice.
- Further, the facility to vote on resolutions through electronic voting system at the meeting was made available to those members who have participated in the AGM and had not casted their votes through remote e-voting till the start of AGM.
